## **Accommodation Fees in Student Dormitories of the University of Economics in Bratislava**

The Rector of the University of Economics in Bratislava is issuing this Appendix 1 to the Internal Directive of the University of Economics in Bratislava (hereinafter also referred to as "EUBA") 1/2022 entitled Accommodation Fees in Student Dormitories of the University of Economics in Bratislava of 31 January 2022.

The EUBA internal directive 1/2002 is amended and supplemented as follows:

**Article 1, paragraph 1** - Monthly student and employee accommodation fees and fees for other accommodation types in EUBA student dormitories (hereinafter "the SD") during the academic year. Accommodation fees for EUBA employees, EUBA guests and outside clients provided are VAT inclusive. Student accommodation is exempt from VAT in accordance with Act No. 222/2004 on value added tax, and is priced as follows:
